The grey zones of intercountry adoption and (some of) their consequences

Hervé Boéchat International Social Service

ISS and its International Reference Center

ISS:

- founded in 1924, to support families whose members are living in different countries;
- a network present in more than 100 countries
- 5000 cases/ year (migration, unaccompanied minors, international family mediation, etc.).

IRC:

- created during the drafting process of the 1994 Hgue Convention;
- funded by 20 countries
- free access for countries of origin
- activities: monthly review, provision of legal expertise, sharing good practices, etc.

<u>Projects:</u> - Assessments of child protection and adoption systems (Moldova 2006, Kazakhstan, Azerbaijan, Kyrgyzstan 2007, Vietnam 2009, Ivory Cost, Guatemala 2010, Laos 2011; Colombia, Haiti, DRC, Ghana 2013, Armenia 2014).

- **Research**: "Investigating the grey zones of ICA" "Finding abuses when searching for roots"

« The grey zones »

- Child production and harvesting: children being "produced" for adoption through paid pregnancies, kidnapping, purchase;
- Forced relinquishment and abandonment: manipulation of birth parents to obtain their consent under false reasons
- Child abduction in emergencies situations
- "Child laundering", or how the child "legally" enters the adoption process

CONCLUSIONS:

- Abuses are taking place before the adoption process itself
- The Hague Convention is not a guarantee per se
- Remedies: legislative reviews, informing prospective adopters, control of adoption agencies, control of money, strengthening cooperation, etc.

Article 8 UNCRC:

- 1. States Parties undertake to respect the right of the child to preserve his or her identity, including nationality, name and family relations as recognized by law without unlawful interference.
- 2. Where a child is illegally deprived of some or all of the elements of his or her identity, States Parties shall provide appropriate assistance and protection, with a view to re-establishing speedily his or her identity.
