Council of Europe Parliamentary Assembly, Recommendation 1443 International adoption: respecting children's rights

"It wishes to alert European public opinion to the fact that, sadly, international adoption can lead to disregard of children's rights and it does not necessarily serve their best interests. In many cases, receiving countries perpetuate misleading notions about children's circumstances in their countries of origin and a stubbornly prejudiced belief in the advantages for a foreign child of being adopted and living in a rich country."

- ICA legislation is inadequate in its accountability in preventing and resolving the consequences of false birth registration
- Amending the Right to Identity with the Right to a Birth Certificate, preventing false birth registration practices
- Responsibility of State Parties, providing support to Adoptees' rights to discover their original families


